2.3 Policy on social responsibility, quality, environment, working environment and the SDGs

The policies below are related to the PDAid Code of Conduct that describes how PDAid act and outlines the company's expectations to its partners and employees within the most relevant business areas.

Overall, PDAid has established the following policies:

Together with our employees and collaborators, PDAid will:

- Show respect for people, animals and nature in any actions undertaken.
- Respect human rights and recognized labour rights wherever business is conducted (Universal Declaration of Human Rights, the Guiding Principles on Human Rights and International Labor Organization (ILO) Convention).
- Aim at the highest standards regarding quality and working environment and at reducing the environmental impact caused by production.
- Set ambitious goals for social responsibility, environmental impact, quality and working environment.
- Comply with legislation and regulatory requirements in every country in which business is conducted.
- Inform, involve, engage and assume co-responsibility for our policy.

According to social responsibility and the United Nations Global Compact, PDAid will:

- Set and assess goals for social responsibility.
- Choose environmentally friendly transport when it is technically and economically viable, for example prioritize ship and train over road and air transport.
- Promote the development of environmentally friendly technologies in cooperation with the countries we work with. This is implemented through collaborations with, for example, local printing companies in the countries where the printed matters (sold products) are distributed.
- Make sure to work with updated electronic systems to ensure safe and correct dissemination without error.
- Advise and provide guidance to organizations and businesses to use environmentally friendly printed matter, for example printed matters produced on environmentally certified enterprises, ecolabelled/FSC approved regulations and rules as well as carbon-neutral production of printed matters.
- Use local raw materials for the production of printed matter (when it is technically and economically feasible).
- Support World Environment Day by encouraging and raising awareness for action to protect the environment.
- Solely cooperate with companies that use the best available and most sustainable technology.

In the quality area, PDAid will:

- Always deliver the agreed quality on time.
- Set and assess goals for the quality improvements.
- Continually assess new quality opportunities for products and processes.
- Improve the quality of cooperation with employees, customers and suppliers.
- Enhance employee competencies by offering continuous learning via for example courses.

In the environmental area, PDAid will:

 Set and assess goals for the environmental improvements which are stated in this policy, the PDAid SDG profile, the company's action plan documents and the annual sustainability report. Monitoring and

- assessing are done via the annual carbon accounting report, risk assessment and individual methods related to particular goals.
- Prepare an annual carbon accounting report and monitor the company's greenhouse gas emissions from its electricity, heating, waste and business travel (emitted from the headquarters in Denmark).
- Keep up to date with the development in the field of cleaner technology solutions in our industry.
- Continually work with and carry out environmental improvements and measurements aimed at reducing the company's impact on the external environment and limit the consumption of natural resources.
- Inform our customers about PDAid's environmental work and motivate them to choose less environmentally damaging products and services preferably eco-labelled.
- Communicate openly on our environmental policy and objectives.
- Create a sustainable development that complies with the ten principles of United Nations Global Compact.
- Be a carbon-neutral company and receive a CEMAsys Climate Certificate™ as proof of purchase of carbon credits to offset greenhouse gas emissions.
- Stay in the association of CO₂ neutral websites in Denmark.
- Strive to protect the environment, including pollution prevention.
- Sort waste in the following fractions: daily waste, organic, electronic, batteries, paper and cardboard, inkjet patrons and toners, spray cans, fluorescent lamps and energy saving light bulbs and miscellaneous small combustibles.

In the area of working environment, PDAid will:

- Identify and highlight all the working environmental nuisances and burdens, and take continuous care to prevent and minimize them, for example:
 - o purchased office furniture adapted to the individual employee
 - o make sure that lighting conditions in the workplace are adapted to the individual employee
 - o make sure that the indoor climate levels fulfill the minimum requirements recommended by the World Health Organization (WHO)
- Set and assess goals for improvements in safety, health and well-being.
- Focus on a healthy and nutritious diet and ensure daily access to fruits and vegetables for all employees in the PDAid offices.
- Encourage employees to actively evaluate their working environment, report nuisances and contribute to finding solutions.
- Give priority to the ISO work and include safety and health conditions when deciding on investments.
- Always consult and involve the employees about topics and any concerns in relation to the working environment.

In support of the Sustainable Development Goals (SDGs), PDAid:

- Focus on SDG 4 (Quality Education), SDG 12 (Responsible Consumption), SDG 13 (Climate Action) and SDG 17 (Partnership for the Goals), but acknowledges the importance of all SDGs – in the PDAid SDG profile, the targets for each SDG is described, including indication and result.
- Integrated the SDGs as a part of the leading elements in PDAid's work with sustainability.
- Distribute an SDG animation film that the company created in 2019. The film explains the 17 SDGs to help viewers get a better understanding of the goals and is free for everyone to download and use.
- Is a "partner company" in the sense that our approach to business is based on SDG 17 (*including targets* 17.16 and 17.17) partnerships are highly valued, and they are a crucial part of how we do business and support other SDGs.
- Seeks to promote and communicate about the SDGs whenever possible as well as inspire others by sharing knowledge about the SDGs (*target 4.7*).
- Runs (since 2015) the PDAid Foundation that supports talented, young individuals from disadvantaged communities through financials means, personal communication and mentorships the aim is to help them become positive change agents (targets 1.1, 4.3, 10.1 and 17.17).

- Supports Sauti Kuu Foundation, an NGO that works with disadvantaged young people, particularly rural youth, to help them and their families utilize locally available resources to improve their living conditions and teaches them recognize, appreciate and use the locally available resources, in particular land, as an asset to elevate themselves out of poverty, through publicity, networking and promotion (targets 1.2, 4.1, 10.1, 12.8 and 17.17).
- Supported a local project in a local project in Randers, Denmark called "The Family House" (Familiehuset) that provides healthcare and offers advice to Danish and immigrant families with young kids support via sponsorship of SDG merchandise and a short discussion on the SDGs related to the project (target 4.2).
- Supports sustainable paper-based choices and has a goal of reducing the amount of paper used in its headquarters by at least 5 per cent per year, while the goal for the subsidiary in Panama is to ensure a continued low paper consumption (targets 12.2 and 12.4).
- Distributes a paper guide, that the company has developed, to help and guide customers in selecting environmentally friendly paper-choices (targets 12.2, 12.4 and 13.3).
- Seeks to minimize our energy and carbon footprint; PDAid buys United Nation-issued emission credits and neutralize our CO₂ emissions in the future, we want to plant trees instead (target 13.1).
- Helps organize an event, "The Big Climb", both aiming to raise money for education. In 2019, the aim was also centered around raising money for equitable distribution of the COVID-19 vaccine (target 3.3).
